

Sewer construction moving forward

The PSD is performing an array of sewer construction in our service area over the next several years, in partnership with the Town of Hilton Head Island and the Community Foundation of the Lowcountry's Project SAFE (Sewer Access for Everyone) charitable fund.

- **The Town** is funding the installation of sewer mains that will provide service to approximately 500 parcels on more than 50 roads. The Town already has committed approximately \$6 million of the estimated \$10 million that will be needed to complete the effort.
- The PSD has secured a \$1.3 million lowinterest (1.9% over 20 years) loan from the South Carolina Water Quality Revolving Fund to pay for the construction of two new sewer lift stations and upgrades to two existing lift stations that are needed to accommodate the Town-funded sewer mains. PSD
 Commissioner Herbert Ford is leading the effort to collect scores of donated easements needed to install the sewer mains. Easements are needed when no prior public nor utility right of way exists along an affected road.
- **Project SAFE** is working to raise \$3 million to provide grants for low- and moderate-income homeowners to connect to the sewer system when it becomes available.

Work currently is under way in the Oakview, Spanish Wells Road, Marshland Road, and Dillon Road areas. Sewer connection now is available on Nazarene Road, Sassafras Lane, Trinh Palace Way, and Rasta Drive, thanks to recently completed work. Construction of the new sewer lift stations is anticipated to wrap up by early 2018.

Hundreds of households on Hilton Head Island are not yet connected to the public sewer system, relying instead on septic systems. Compromised by unsuitable soil conditions, the high water table and dense underground root systems, some of these septic systems are producing an overflow of contaminated waste water that threatens the safety and beauty of our island home.

Water contamination caused by septic systems affects every single one of us. **It affects our health.**

When the water table rises, so does the level of unsafe, untreated waste water. Backyards get filled with bacteria, which can lead to a variety of illnesses. **It affects our environment.**

Contaminated waste water from septic systems – carrying detergents, soaps, bleach and other unsafe chemicals – runs off into Port Royal Sound, the May River, Jarvis Creek, Broad Creek, the Colleton River and the Atlantic Ocean, threatening the ecological health of our waterways, shellfish beds and marine life.

It affects our economy.

The effects of waste water contamination endanger our world class Hilton Head Island resort brand, our beautiful natural environment and the livelihoods of the people who make their living serving our 2.1 million annual visitors. **You can help.**

Public sewer connection can be cost prohibitive for households struggling to make ends meet. So Community Foundation of the Lowcountry, Hilton Head Public Service District and the Town of Hilton Head Island have come together to address the issue of septic systems.

The Town of Hilton Head Island has allocated over \$10 million to bring sewer mains to areas of the Island still unserved. Hilton Head PSD is performing the sewer construction work. But that doesn't finish the job – and the Town and PSD can't do it alone. That's where Project SAFE (Sewer Access for Everyone) comes in.

Through Project SAFE, Community Foundation of the Lowcountry will raise the remaining \$3 million in funds needed to connect low-income homes to the public sewer system, eliminating the septic systems that are failing us all. It's time for those who can contribute to come together to raise the money for those who cannot afford to make the connection.

The PSD is performing an array of sewer projects as part of a Town of Hilton Head Island-funded effort to provide access to the public sewer system in neighborhoods that had lacked access. Recent work has been performed on Chisolm Place, in the Oakview area and the vicinity of Marshland and Spanish Wells roads. As part of the effort, the PSD is funding the construction of two new sewer lift stations and upgrades to two existing lift stations, in order to accommodate the new sewer lines funded by the Town.

PSD water quality lab recognized as Laboratory of Excellence

The PSD's water quality laboratory has been recognized as a Laboratory of Excellence as part of its annual certification by the S.C. Department of Health and Environmental Control (DHEC). The independent agency that conducts DHEC's certification recognized the PSD lab for "achieving 100% acceptable data" in a group of more than 600 participating labs, according to a statement from the independent agency. "This achievement is a demonstration of the superior quality of the laboratory," according to the statement. The PSD water quality lab conducts thousands of tests annually on the quality of our tap water and treated recycled wastewater. The lab is led by PSD water quality chemists Scott Moffatt and Lee Barnard.

Water Wisely and Create a True "Carolina Yard"

Hilton Head PSD partners with Clemson University Extension Service to provide customer education about responsible lawn care and landscaping in the Lowcountry. Clemson's "Carolina Yards" program promotes a set of landscape principles that will help you save water while simultaneously developing a beautiful and beneficial home landscape. According to the Extension Service, a truly efficient way to use water in a yard is to design the yard so that it thrives predominantly on rainfall. Even if your yard has a lawn and specialty gardens, it is possible to design it as a "Carolina Yard" in which you can water the plants "as needed."

However, even an ideal landscape design can be overwatered. The Extension Service points out that many of the actions you'll need to take deal with sprinkler systems. It's extremely important that each irrigation zone is set to meet the needs of the plants in that area. For example, a lawn in full sun will demand more frequent irrigation than an established plant bed of shrubs and groundcovers. Carolina Yards Water Wisely Action Checklist:

- Put a rain gauge in your yard and track rainfall to avoid unnecessary watering.
- Water your lawn and other plants only when they show signs of stress. Comply with any existing watering restrictions in your community.
- Use a drip- or micro-spray irrigation system to more

efficiently water plants and plant beds.

- Design or modify your sprinkler system to water lawn areas separately from plant beds, which require less water.
- Walk your yard when the irrigation system is on to ensure that water is being applied to lawn and plant beds only and not the pavement.
- Calibrate your sprinkler(s) to apply 1/2 to 3/4 inch of water per application.
- Connect an automatic rain shut-off device to your sprinkler system's timer and set the device to 1/2 inch so it will override the timer when enough rain has fallen. Check to see if the shut-off device is working properly.
